**Freedom of Information Act 2000 Request Tender Information - labels, signage, tags**

I refer to your FOI request as below.

1. The spend on labels for the year 2015/16 on all purchases plus break down
2. The spend on water proof tags for the bin collection plus break down
3. Any labels/tags that have been purchased by the city of derry airport plus break down
4. The spend on signage in the derry/strabane area to include all signs/banners/ graphics plus breakdowns

**Response:**

You will be aware, Section 12(1) of the FOIA contains a provision that allows a public authority to refuse to comply with a request for information where the cost of compliance is estimated to exceed a set limit known as the appropriate limit. For local authorities, this limit is set at £450 - The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244 refers.

I would advise that due to the number of invoices involved for numerous marketing related purchases including but not specific to signage, graphics, branding, labels etc from various companies, Council estimate that the cost of compliance in providing a breakdown of all purchases is in excess of the appropriate limit and Council therefore apply the exemption contained in Section 12 for questions 1 and 4.
