Location: Townlands of Altgolan and Meenclogher, Killen, Castlederg Strabane Co. Tyrone; Site entrance 158 M. North of No. 94 Scraghy Road, Killen, Co. Tyrone, BT81 7SL

Proposal: Planning application for new Altgolan Wind Farm consisting of 5 No. wind turbines with a tip height of up to 149.99m, new access tracks, widening of existing tracks, hardstanding areas, a control building and all associated ancillary infrastructure. The proposal will have an operational period of 35 years from the date the wind farm is connected to the electricity grid.

Previous consents relating to Altgolan Wind Farm are 2012/A0070 (J/2006/0840/F), LA11/2016/0649/F, LA11/2018/1004/F and LA11/2020/0916/NMC. The current application proposes an amendment to the wind turbine dimensions, including an increase in wind turbine tip height from 125 Metres to up to 149.99 Metres, slight amendments to the consented locations of the wind turbines and minor alterations to the previously consented access track layout, hardstanding design and control building location. The application will also

change the wind farm operational period from 30 years to 35 years from the date the wind farm is connected to

the electricity grid

In support of the above planning application Further Environmental Information (FEI) has been submitted in respect of an updated Outline Construction Environmental Management Plan, impacts on karstic features; updated Habitat Management Plan; updated ecology reports; information on indicative grid connections.
