- Dfl advised that a letter had been received in relation to LA11/2021/0906/F and in advance of any response we wanted to gain a better understanding of the case. Asked about any potential significant issues, ongoing discussions with the applicant/NIEA and views/action in relation to the 2017 EIA Regulations.
- The Council confirmed that they were aware of concerns and that they were working with the applicant & NIEA to try to resolve any outstanding issues related to the site.
- The Council confirmed that an enforcement notice had been served but that this was pending the outcome of the application.
- Dfl sought confirmation as to whether the Council was satisfied that the proposal was not EIA development.
- The Council remain of the view that the development does not constitute EIA development and are content with this position at this stage.

Conclusion

- The discussions raised no issues of concern which would merit the Department's intervention.
