I refer to your EIR request and respond as follows:

**Request:**

We are currently looking for information for a site in regard to an Environmental Assessment. The site is located at **Strand Road, Derry/Londonderry**. We would be grateful if you could provide the following information at or in the vicinity of the site (a 500m radius search would suffice):

- any contaminated land information
- records of land (and water if available) pollution incidences
- known sources of contamination
- landfilled areas
- industrial installations in the vicinity
- groundwater abstraction borehole records; and,
- any other relevant information / records you may have

**Response**

- The Environmental Health Service holds no records of contaminated land within 500m of the aforementioned site.
- The Environmental Health Service holds no records of land pollution incidents within 500m of the aforementioned site.
