## **Environmental Information Regulations Request - Wind turbine Site on Curlyhill Rd, Castletown Strabane**

I refer to your EIR request and respond as follows:

**McCloy Consulting have been appointed to undertake a water and geology assessment in support of a planning application for the demolition of an existing single wind turbine and installation of a new single turbine on lands c.420m east of 53 Curlyhill Rd, Castletown Strabane, BT82 8LR.**

**The site centroid is IGR 236847, 397947– and is shown below.**

**As part of this assessment, we are required to assess the current baseline hydrological conditions and review the impact of the proposed development on water abstractions in the area.**

**We would be grateful if the Council could provide the following in order to assist with the assessment:**

- 1. The location and details of all Private Surface Water Supply Abstractions / Intakes within the downstream catchments of the site that the council has on record.**
  - Any associated water quality data**
  
- 2. The location and details of all Private Groundwater Abstractions / Intakes within 5km of site**
  - Any associated water quality data**
