











Road Traffic Regulation (Northern Ireland) Order 1997 Notice of Proposed Road Closures for a Special Event

Notice is hereby given that, by virtue of the powers conferred on it by Article 8A of, and Schedule 3A to, the Road Traffic Regulation (Northern Ireland) Order 1997, Derry City and Strabane District Council is minded to make an Order to temporarily restrict or prohibit vehicles and/or pedestrians from using the roads detailed in, and in accordance with, the following schedule. The Order will facilitate a special event, a 10 Mile Road Race, which will take place on Saturday 11 March 2023 and which is being organised by City of Derry Spartans AC.
