Freedom of Information Act 2000 Request - Landfill Sites

I refer to your FOI request and respond as follows:

- 1. Could you please provide relevant information regarding both working and legacy landfill sites in the Derry/ Strabane area and the volume that they have.**

Culmore Landfill Site, 39 Coney Road, Derry, BT48 8JP

Culmore Landfill Site is located approximately 1.5km of the A2 Derry to Muff Road. It is located approximately 6km northeast of Derry City Centre and 1km from the main clustering of houses at Culmore. The site covers a total area of 40 hectares. Planning permission was granted for landfilling operations at the site by the Government of Northern Ireland Ministry of Development in November 1971. The site was developed on land reclaimed from Lough Foyle and waste filling continued until March 2007. The site accepted up to 75,000 tonnes / annum of domestic, commercial and inert waste. The site was remediated and restored to a public park. The park facilitates a mixture of passive and active recreational areas, developed natural habitats and increased biodiversity in the area.

Duncastle Road Landfill Site

This is a decommissioned landfill site located to the east of the B48 Duncastle Road approximately 1.4km south of New Buildings. The roughly 11 Ha sites was used for the disposal of municipal waste between 1980 and 1987. Landfills that closed before July 2001 are not subject to the closure requirements of the

Carricklee Landfill Site

Operated by Council in the Strabane area. This site was closed circa 2000. Council does not hold any further detail with regard to this site.

Spamount Landfill Site

Closed landfill site in the Strabane area. Council does not hold any further detail with regard to this site.

- 2. Also, could you provide the green waste recycling and food waste volumes that you have handled in the years 2019 to 2024 and also in what way are these recycled. This is under the Freedom of Information act.**
