Initial Statement of Community Involvement (SCI) – July 2016

The Planning (Statement of Community Involvement) Regulations (Northern Ireland) 2015, Regulation 5

Statement of Community Involvement (SCI) Consultation

- **5.**(1) Before preparing a statement of community involvement, a council must also **consider whether it is** appropriate to invite representations from persons who have an interest in development in its area.
- (2) If a council decides that it is appropriate to invite representations under paragraph (1), it must make such arrangements for the purposes of inviting representations from such persons of the descriptions in paragraph (1) as it thinks appropriate.
- (3) In preparing the statement of community involvement, the council must take into account any representations made to it in response to invitations under paragraph (1) or (2).

In accordance with the above Regulation, the Council decided that it would be appropriate to invite representations in preparing its first Statement of Community Involvement (SCI) for the Council's Planning functions (both LDP and Development Management functions).

In drafting the SCI, it was considered / discussed on several occasions during 2015 with the elected Members, on the Council's Planning Committee and its Environment & Regeneration Committee. Following the Member agreement, the draft SCI was then made available for Public Consultation between 24th November 2015 and 8th January 2016. The consultation period was advertised (see below) in the local newspapers in the week commencing 23rd November 2015 (the Derry Journal, the Londonderry Sentinel, the Ulster Herald, the Strabane Chronicle, the Tyrone Constitution and the Strabane Weekly News), as well as the Council website. Continuing press coverage was provided, with a 3rd December 2015 photo promotion featuring the Mayor and senior Planning Officers.

Copies of the document and consultation forms were made available at the Planning Office in Orchard House, at the Council Offices at Strand Road and Derry Road, Strabane and at the local leisure centres throughout the District (Foyle Arena, Templemore Sports Complex, Brooke Park Leisure Centre, Derg Valley Leisure Centre, Riversdale Leisure Centre and Melvin Sports Complex).

The public were able to submit their consultation responses via the LDP page of the Council's website, on Facebook and Twitter and via email.

The Council's Marketing and Communications team assisted with the electronic distribution of the draft SCI to approximately 350 e-mail addresses on the Council's approved consultation list. Strategic Planning Division of DOE were also emailed a copy of the document and asked for initial comments. Members of the Planning Committee were reminded in January 2016 of the ongoing consultation and to send any response before the closing date. General feedback from Members and officers on Planning issues - both urban and rural, was also taken on board.

Seven responses were received and those comments were taken into account in the preparation of the Council's first SCI in 2016. In summary, the representations sought the use of 'plain English', minimising un-necessary jargon, support for public engagement and equality for all throughout all of the District.

When the SCI was prepared, it was approved by the Council's Planning Committee on 2nd March 2016 and was duly approved by the full Council on 4th April 2016. DOE Planning was consulted and provided feedback in January and May 2016, and then in accordance with Regulation 6, Dfl Planning's (DOE name had changed) agreement was received on 14th June 2016 – see agreement letter at DS-600a.

The SCI was duly published and, in accordance with Regulation 7, it was made available for inspection at the Council's principal offices during normal office hours, advertisements were placed in the local newspapers (w/c 4th & 11th July 2016) and the SCI was published on the Council's website, together with PR (including Planner magazine & online).

Derry City and Strabane District Council are commencing preparation of our new Local Development Plan (LDP) 2030, in accordance with the Planning Act (Northern Ireland) 2011 and the Planning (Local Development Plan) Regulations (Northern Ireland) 2015. When adopted, the LDP will replace both the Strabane Area Plan 2001 and the Derry Area Plan 2011.

Please find enclosed a copy of the proposed Local Development Plan Timetable. We anticipate sending this timetable to the Department for Infrastructure in early June for their agreement, prior to an end of June publication. The publication of the agreed Timetable will mark the formal commencement of the LDP process. The Timetable meets the requirements of the Planning Act (Northern Ireland) 2011 and the Planning (Local Development Plan) Regulations (Northern Ireland) 2015, which require Council to prepare and keep under review a Timetable for the preparation and adoption of its LDP. Derry City and Strabane Council are also legislatively required to consult consultation bodies, as per Part 2, Regulation 5 of the Planning (Local Development Plan) Regulations (Northern Ireland) 2015.

This Timetable sets out an indicative timescale along with the associated key stages for the production of the LDP. It is a public statement of our programme for the delivery of the LDP. The timetable will help ensure that the plan process is efficiently managed and that all involved in its preparation are kept informed and can manage their own resources to facilitate their involvement in the LDP process. Derry City and Strabane District Council acknowledges that this Timetable will be challenging for all involved, given limited resources.

I trust that you find this Timetable acceptable in terms of your own work commitments and involvement with other LDPs. I look forward to working with you. If you have any comments please forward them to the Local Development Plan Team by 3rd June 2016.

The Planning (Local Development Plan) Regulations (Northern Ireland) 2015, PART 3, Regulation 9

Preparation of the preferred options paper

- 9. (1) Before a council complies with regulation 11, it must, for the purpose of generating alternative strategies and options, **engage the consultation bodies**.
- (2) In preparing the preferred options paper the council must take into account any representation received from the consultation bodies.

In accordance with Regulation 9, the Council undertook an extensive programme of engagement with the stipulated 'consultation bodies', and then took into account any representations received. Specifically, there was engagement with:

- a) The NI Government Departments
- b) The adjoining councils, namely Fermanagh & Omagh District Council, Causeway Coast & Glens Borough Council, Mid Ulster District Council and also Donegal County Council
- c) NI Water
- d) NI Housing Executive
- e) The Civil Aviation Authority
- f) Electronic Communications Code firms
- g) Electricity Licence holders
- h) Gas Licence holders

Firstly, a **general engagement / consultation letter** was issued to all of the identified consultation bodies, at the end of November and into December 2016. The following typical letter was issued, and then chased-up in January / February 2017, to all on the **MASTER CONSULTEE Contact List, POP Stage** - see below.

The responses from the government departments and also from the adjoining councils, are summarised in the **tables below**.

Then in Spring 2017, the Council hosted a series of focussed Engagement Meetings / Events, in order to ensure meaningful input and discussion on the issues and options for the POP. These involved:

- 1) a meeting of senior LDP Planning officers from the 5 adjoining Councils on 1st March 2017 **see invite letter** and **agenda** below
- 2) a key consultee event on 9th March 2017 see **invite**, **agenda** and **minute / attendees** below (all of whom are consultation bodies). Key consultation bodies were issued with a follow-up topic paper and Draft POP chapter, for comment / agreement prior to finalising, in late March / early April 2017
- 3) there was also a major Stakeholder event held on 4th April 2017, including several consultation bodies see **invite** and **agenda** below
- 4) an event for Planning Agents was held on 21st March 2017, followed up with letters to a database of Agents on 27th March.
- 5) there had also been 10 topic-based Discussion Workshops with the Elected Members during 2016, plus a Member Workshop on 13th April 2017 (before Planning Committee discussion / approval on 26th April and Full Council on 8th May 2017).





Statement of Community Involvement (SCI) Consultation

- **5.**(1) Before preparing a statement of community involvement, **a council must also consider whether it is appropriate to invite representations** from persons who have an interest in development in its area.
- (2) If a council decides that it is appropriate to invite representations under paragraph (1), it must make such arrangements for the purposes of inviting representations from such persons of the descriptions in paragraph (1) as it thinks appropriate.
- (3) In preparing the statement of community involvement, the council must take into account any representations made to it in response to invitations under paragraph (1) or (2).

In accordance with the above Regulation, the Council decided that it would not be required, or appropriate to invite representations before preparing its Revised Statement of Community Involvement (SCI). The original SCI had been subject to significant public consultation, but it yielded very limited useful comment or input so it was considered to be un-necessary at this Revision stage.

When this Revision 1 of the SCI was prepared, it was approved by the Council's Planning Committee on 7^{th} March 2018 and was duly approved by the full Council on 29^{th} March 2018. Dfl was consulted in accordance with Regulation 6 and its agreement was received on 24^{th} May 2018 - see agreement letter at DS-600a.

The SCI was then published and, in accordance with Regulation 7, it was made available for inspection at the Council's principal offices during normal office hours, advertisements were placed in the local newspapers (w/c 25th June & 2nd July 2018) and the SCI was published on the Council's website. Full details of this publicity is included at DS-600b.

In accordance with the above Regulation, the Council consulted the PAC but decided that it was not appropriate to formally consult with the key consultees or other Consultation Bodies. As the Council explained in the Revised Timetable document (para 1.2) this Revision was considered to be necessary - in the light of experiences of the POP preparation and its subsequent consultation, as well as the greater knowledge of the processes and practicalities of LDP preparation. As such, this Revised Timetable was considered to be more of a 'statement of fact' rather than something that could be usefully 'consulted upon' or opinions sought. The Council was still determined to proceed with the key stages of LDP preparation, in the most expeditious manner, by its best-endeavours but recognising that this was a new plan-making system and there were many aspects beyond the control of the Council. Additionally, the informal feedback from the bodies previously consulted - with whom the Council was working closely, was that they would have little that they could usefully contribute to any consultation exercise at that stage, as long as they were kept notified of the Revised Timetable.

Therefore, the consultation at this stage was limited to the statutorily-required Planning Appeals Commission and DfI Strategic Planning: the agreement from PAC on 18th April 2018 and subsequently the agreement of DfI on 24th May 2018 (Reg. 7). These two approval letters are included in document DS-600a.

In accordance with Regulation 8, the final LDP Timetable – Revision 1 document was issued to the key consultees, made available for inspection during normal office hours at the Council's principal offices, it was locally advertised, PR was done in the press and social media and the Timetable was published on the Council's website; see DS-600b for details.





Statement of Community Involvement (SCI) Consultation

Proposed Changes (PCs) to LDP draft Plan Strategy (dPS) – Consultation for PC Comments, December 2021

The Planning (Local Development Plan) Regulations (Northern Ireland) 2015 PART 5

Development Plan Practice Note 10: Submitting Development Plan Documents for Independent Examination (DPPD 10 - Dfl – December 2019)

The Council is required to prepare the LDP, taking account of all Departmental Guidance, including DPPN 10 - which provides the key guidance to Councils on how a DPD progresses from the representation stage to submission to the Department. In particular, paragraphs 4.1 to 4.11 advise on how the Council can respond to the Representations it has received, as well as to any significant changed circumstances. This DPPN introduces a 'non-statutory administrative stage' in the LDP-preparation process, whereby the Council can identify 'Minor changes' and 'Focussed Changes' that it believes should be brought forward, as an Addendum to the LDP dPS - all of which can be considered by the PAC at the Independent Examination.

The DPPN guides the Council, saying that in order for the focussed changes to be considered at the IE, satisfactory consultation should take place; therefore, a Council should prepare, publish and **consult upon the focussed changes.** The addendum of focussed changes, together with an SA and other statutory assessments (as required), should be published for consultation for a period of 8 weeks which corresponds to the timeframe specified in Regulation 16.

Derry City & Strabane District Council, in taking account of this Departmental Guidance, has published a Schedule of Proposed Changes, all of which has been advertised and consulted upon in accordance with the above guidance, similar to that done for the original dPS itself - under Regulation 16 / PART 5 of the Planning (LDP) Regulations (NI) 2015.

Though this is a non-statutory administrative stage, arising from DPPN 10, the requirement to make available, advertise and consult – was considered to be similar to that specified for the earlier DPD stages; therefore, it was all undertaken in the normal manner.

The Council has now agreed to a number of Proposed Changes to the LDP draft Plan Strategy, primarily arising from our consideration of the received Representations (Reps) and Counter Reps. Submission of LDP dPS and associated documents, April-May 2022

The Planning (Local Development Plan) Regulations (Northern Ireland) 2015, PART 5, Regulation 21

Availability of submission documents

21. As soon as reasonably practicable after a council submits a development plan document to the Department it must—

(a) make the following documents available for inspection at the places referred to in paragraph (b) -

(i)a copy of the development plan document,

(ii) the documents specified in regulation 20(2), and

(iii)such other documents as in the opinion of the council are relevant to the preparation of the development plan document;

(b)the places referred to in paragraph (a) are—

(i)the council's principal offices, and

(ii) such other places in the district of the council as the council considers appropriate;

(c)**notify the consultation bodies** of the fact that the development plan document and the documents mentioned in paragraph (a) are available for inspection and the places and times at which they can be inspected;

(d)**notify any person who has made (and not withdrawn) a representation** in accordance with regulation 16(2) or 18(2) of those matters;

(e) give notice in the Belfast Gazette and **by local advertisement** of the fact that the development plan document has been submitted to the Department; and

(f)publish the notice mentioned in paragraph (e) on its website.

As soon as possible after the Council submits the LDP documents to DfI, it shall publish, make them available, notify and advertise – all as per the above-mentioned requirements.
