Health and Safety at Work (NI) Order 1978 – main duties


Article 4 – General duties of employer to their employees –

- to ensure health safety and welfare at work of all their employees.
- to provide safe plant and systems of work.
- to provide such information, instruction, training and supervision.
- the maintenance of a safe place of work and safe access and egress.
- The provision and maintenance of a safe working environment and adequate welfare facilities

## Article 5 – General duties of employers to persons other than

#### their employees -

 Employers to ensure customers, visitors, members of the public etc are not exposed to health and safety risks from their undertakings



## Health and Safety at Outdoor Events

The Management of Health and Safety at Work Regs (NI) 2000 Regulation 3 – Risk Assessments

Employers to make a suitable and sufficient assessment of the risks to health and safety of his employees and to others in connection with his work/undertaking to identify the control measures the he needs to take to ensure compliance with relevant health and safety legislation.



- Ensure staff you use are Competent
- Clearly define their Roles and Responsibilities
- Assess your Venue Suitability
- Produce your Health and Safety Policy
- Appoint Competent Contractors seek evidence/certificates
- Produce an Event Management Plan

# **Electrical and Gas Safety**

- Gas systems must be maintained as per manufacturers instructions, this includes the ventilation system
- Maintenance must be carried out by a competent person (e.g. Gas Safe Registered Engineer)
- Seek up-to-date Gas Safe Certificate for hired in catering units.
- Gas cylinders must be stored in open air and secured.
- Electricial systems should be installed by a competent person (NICEIC, RECI etc) and a suitable sign off certificate obtained.
- Diesel or LPG fuelled generators.
- 95% of faults can be picked up visually
- Portable Appliance Testing (PAT) certificates for plug in appliances and extension leads etc.
- Portable Fire Fighting Equipment available in prominent position, maintained and trained person to use same.

# **Welfare and Toilet Facilities**

#### **Drinking Water**

HSE recommendation of free drinking water of 1 outlet per 3000 people and 1 outlet per 10 caterers.

### **Toilet Facilities**

HSE and Purple Guide provide recommendations for minimum toilet numbers:


Events with a gate opening of 6 hours or more:

1 Toilet per 75 females 1 Toilet per 400 males with 1 urinal/100

#### Events with a gate opening of less than 6 hours:

1 Toilet per 100 females 1 Toilet per 425 males and 1 Urinal/125

Remember these are minimum requirements



# **Fireworks and Special Effects**

- Firework displays require a licence from the Dept of Justice – 6 weeks
- Display must be planned and managed by a competent person.
- Firework display require a large site to allow for safe separation and fallout.
- Stage pyrotechnics require careful selection and adequate separation distance from performers and audience.
- Site specific RA and safety plan required for fireworks and special effects due to increased risk to public safety and fire.
- Tommorowland Unite Festival Spain -22,000 fans evacuated when stage caught fire due to special effects
