 - Town Clerk & Chief Executives salary for 2015/16 Year = £100,000 (Gross) per annum from 1st April 2015 – 31st March 2016. This is the second point of a four point scale and forms part of the agreement reached for Band 3 (Derry & Strabane District Council) Chief Executive salary scales: 2014:2016 (for - New Councils). In addition he is also paid £1,239.00 (Gross) Essential Car user Allowance per annum.
