- In 2018, there were 5,260 businesses, registered for VAT and/or PAYE, operating within the DCSDC area. This made up 7.0% of all such businesses within NI.

- In line with the trend experienced across NI, the number of VAT and/or PAYE registered businesses within DCSDC has shown an upward trend from 2015. The number of businesses in operating within DCSDC increased by 630 from

2015 to 2019, an increase of 13.6%. Within NI, the number of businesses increased by 10.9% over the same period.

- The largest industry group in DCSDC and NI is Agriculture, Forestry and Fishing, accounting for just under a quarter (24.0% and 24.5% respectively) of all VAT and/or PAYE registered businesses.
- Outside of Agriculture, the largest industry group in DCSDC is Construction (16.0%) and then Retail (8.7%).
- DCSDC has a higher proportion of its industry in these three groups compared to NI. DCSDC also has a higher reliance on the Health Industry.
- However, it then has a lower dependence on those industries allied to professional services (IT, Professional /Scientific, Business support).

- In 2018, there were a total of 1,771 farm businesses in DCSDC.
- 1,453 (82.0%) of farms were operating in Less Favoured Areas (LFA) compared to 69.5% of all farms in NI.
- DCSDC had a higher proportion of large farms² with 7.2% (128) of all farms falling into this category compared with 6.8% in NI.

² Farm business size is determined by calculating each farm's total Standard Labour Requirement (SLR). Large farms require 3 or more SLR.

- In 2016, the income generated by businesses in DCSDC, less the cost of goods and services used to create this income was estimated to be £1,231.0 million. This amount represents the approximate Gross Value Added (aGVA) at basic prices of the NI non-financial business economy, excluding farming and financial services.
