I refer to your FOI request and respond as follows:

1. How many dog attacks on humans were reported in the years 2021-2025?

• 1 st January to 31 st December 2021	33
• 1 st January to 31 st December 2022	53
• 1 st January to 31 st December 2023	55
• 1 st January to 31 st December 2024	57
• 1 st January to 16 th October 2025	33

Please note that Derry City and Strabane District Council through its Tascomi management information system provide the Department of Agriculture, Environment and Rural Affairs (DAERA) with statistical information on a wide range of dog control service areas including dog attacks on people, livestock, and domestic animals figures inter alia. This information is provided by all Councils in Northern Ireland on a quarterly basis, collated and held by DAERA. It is then referred to by Councils and DAERA when providing responses to dog related information requests from the media, the public and animal welfare stakeholders.
