Local Development Plan 2032 Planning Department Planning Our District's Future Purpose: The purpose of this interim progress report is to set out the legislation, the process of EQIA, the baseline and an initial screening assessment of the potential impact of the proposed POP proposals on Section 75 Groups.

1.0 Introduction

- 1.1 This interim progress report has been prepared alongside the Derry City and Strabane District Council's Preferred Options Paper published in May 2017.
- 1.2 The Preferred Options Paper provides the basis for consulting with the public and stakeholders on a series of options for dealing with key issues in the Plan area. It aims to stimulate public comment and help interested parties to become involved in a more meaningful way at this earliest stage of the plan preparation. Effective community and stakeholder engagement also strengthens the evidence base which in turn is used to inform the preparation of the Preferred Options Paper.

2.0 Legislative Context

Section 75 of The Northern Ireland Act 1998, Equality of Opportunity places a statutory duty on each public authority in carrying out their functions relating to Northern Ireland to have due regard to the need to promote equality of opportunity-

- a) between persons of different religious belief, political opinion, racial group, age, marital status or sexual orientation;
- b) between men and women generally;
- c) between persons with a disability and persons without; and
- d) between persons with defendants and persons without.
- 2.2 The principle of promoting equality of opportunity and good relations between people is a key objective behind the Local Development Plan and will be an important theme of the Sustainability Assessment.
- 2.3 The Disability Discrimination (NI) Order 2006 introduced new duties requiring all public authorities in carrying out their functions relating to Northern Ireland, to have due regard to the need to
 - a) promote positive attitudes towards disabled people; and
 - b) encourage participation by disabled people in public life.
- 2.4 As part of the Derry City and Strabane District Council's Local Development Plan an Equality Impact Assessment will be completed for both the Draft Plan Strategy and Draft Local Policies Plan to ensure these requirements are met.
- 2.5 To inform the Preferred Options Paper the Council has prepared a series of Topic Papers on a wide range of planning related subjects. Of particular importance is Topic Paper 1: Population and Growth Strategy. This Paper, provides a profile of the population of the District including, the different Section 75 groups of people, identifying how the Plan can impact on them. This paper alongside the other Topic Papers, has been used to inform the key planning issues facing the District and in the preparation of the Preferred Options Paper which identified these key issues and presents a number of options for addressing these within the Local Development Plan and indicates the Councils preferred option. The options presented are not policy, but rather are suggestive of a policy approach.
- 2.6 At this early stage of the plan making process we have carried out an initial equality screening assessment of our preferred options by identifying the key planning issues facing our District and assessing the potential impact on Section 75 groups. (Table1). As the plan progresses we will continue to carry out screening of our proposals and carry out a full EQIA to assess the impact of our proposals on the Section 75 groups.
- 2.7 A further initial assessment is carried out of the Preferred Options policies in relation to the Section 75 groups. (Table 2)

3.0 Overall Impacts

- 3.1 The main purpose of this interim EQIA is to ensure that the LDP will have due regard to the need to promote equality of opportunity from the very onset of policy formulation. The table above highlights that the Preferred Options will have differing impacts on the Section 75 groups, both positive and negative. Where negative impacts are identified as likely at this stage, mitigating measures can be considered in the later stages of the LDP process.
- 3.2 The potential impact of the LDP will only be realized when the LDP is fully developed. Equality Assessment will be undertaken at each stage of the LDP Process.
- 3.3 The Equality Assurance and Overview Group of the Inclusive Strategic Growth Plan 2017-2032, comprises representatives from Section 75 categories, and rural and deprived communities. This group will have responsibility for monitoring progress against equality indicators and targets, identifying emerging issues and providing feedback to the Community Planning Partnership. The LDP POP is statutorily linked to the Inclusive Strategic Growth Plan and as such the Equality Assurance Overview Group will contribute to the EQIA for the Local Development Plan.

4.0 Moving forward

- 4.1 The Preferred Options Paper and EQIA will be subject to a 12 week period of public consultation. However, the Council will also carry out a specific focused consultation with representatives from the Section 75 groups with support from Derry City and Strabane Councils Equality Officer, a list of these potential consultees can be seen in Appendix 1 (This list is subject to change).
- 4.2 Following the POP consultation and this Interim EQIA report, all feedback and representations received, including from Section 75 Groups or relating to relevant policies / proposals, will be fully considered and the Council will proceed to prepare the LDP Plan Strategy and later the LDP Local Policies Plan. Each of these LDP documents will be accompanied by a full EQIA report, for consultation and consideration at the respective Independent Examinations.
