The following are some further comments to highlight specific issues that are likely to affect the soundness of the LDP Plan Strategy

Evidence Base

As per previous requests, and to meaningfully engage with the process of preparing the draft Plan Strategy, it is critical that the evidence base used by the Council is made available as part of the consultation, including the Urban Capacity Study. It is respectfully requested that the complete evidence base for the plan is made available at the earliest opportunity.

Plan Period

The preparation of the draft Plan Strategy is significantly delayed. Taking a pro rata approach with the plan timetable, it would be reasonable to assume that the Local Plan Policies will be adopted in 2026, meaning the life of the plan is reduced to only 6 years. It is imperative that the LDP delivers upon the objectives of the Strategic Growth Plan, but with only 6 years remaining, you should reconsider revising the plan period.
