Executive Summary

Derry City and Strabane District Council conducted an Equality Impact Assessment (EQIA) for its Local Development Plan (LDP) Draft Plan Strategy (dPS), published on 2nd December 2019. A first Addendum was released in November 2021 alongside the Council's Proposed Changes. Both the original EQIA and the first Addendum underwent public consultation, with no concerns raised.

The dPS and related documents were submitted to the Department for Infrastructure (DfI) in May 2022, leading to an Independent Examination (IE) by the Planning Appeals Commission (PAC) between September and October 2023. The PAC's report in May 2024 concluded that the dPS was sound, subject to certain amendments. The DfI accepted these findings and issued a Direction on 17th December 2024 for the Council to adopt the dPS with Modifications. An updated Direction followed on 5th February 2025 to correct minor errors.

This Second Addendum to the EQIA has been prepared to assess the equality impacts of the Modifications in the Dfl's Direction that had not been previously evaluated. The assessment determined that these Modifications do not materially alter the conclusions of the original EQIA or its first Addendum. It concluded that the dPS is unlikely to have an adverse impact on Section 75 groups, either directly or indirectly.

The Second Addendum was published for public consultation between 19th March and 1st May 2025, during which time 12 representations were received. Of these 12, 2 contained comments on the EQIA document and/or comments relating to equality issues and Section 75 groups generally. In addition to considering the Modifications contained in the Dfl Direction, this report addresses the comments contained in the representations received through the public consultation exercise.

This Addendum to the EQIA comprises the following stages:

- Screening of any Modifications to the dPS that are within Dfl's Direction and have not been previously assessed to determine if any of the Modifications materially change the outcomes of the Equality Impact Assessment i.e. whether they alter the assessed impact that the LDP Plan Strategy is likely to have on Section 75 groups or the influence equality considerations have had on the LDP Plan Strategy;
- Undertake an assessment of the Modifications that have not been screened out.
- Consideration of public consultation comments
- Conclusions of the assessment of Modifications to the LDP draft Plan Strategy in the context of the requirement to have due regard to impacts on Section 75 groups and the need to promote equality of opportunity.

1.0 Introduction

1.1 An Equality Impact Assessment (EQIA) of the LDP Draft Plan Strategy (dPS) was prepared by Derry City and Strabane District Council and published on 2nd December 2019, alongside the Council's dPS and other associated assessment documents. An Addendum to the EQIA was subsequently prepared and published in November 2021 alongside the Schedule of Proposed Changes to the dPS. Both the original EQIA and the Addendum were subject to formal consultation, alongside other published Local Development Plan (LDP) documents, as part of the plan-making process. None of the representations received during the consultation raised any issues regarding the EQIA or its first Addendum.

1.2 This document, serving as the Second Addendum to the EQIA, has been prepared in relation to the DfI Direction to the LDP Draft Plan Strategy (dPS). It identifies whether the outcomes of the EQIA should be amended as a result of the Modifications to the dPS or as a result of comments received through the public consultation exercise. This Addendum should be read in conjunction with the original EQIA and first Addendum, published in November 2021.

Independent Examination and Department for Infrastructure Direction

- 1.3 Following the submission of the Draft Plan Strategy (dPS) and associated documents to the Department for Infrastructure (DfI) for Independent Examination (IE) on 26th May 2022, DfI appointed the Planning Appeals Commission (PAC) on 20th September 2022 to conduct the IE. The hearing took place from 5th September to 4th October 2023, during which the Council introduced additional proposed further changes for consideration. Subsequently, the PAC produced a report on the dPS and the Council's proposed changes, concluding that the dPS met the required tests of soundness, subject to recommended amendments. These PACrecommended amendments were made in accordance with Section 10(8) of Part 2 of the Planning Act (NI) 2011. Paragraphs 1.23-1.25 of the PAC report affirmed that, the Council's EQIA on the draft Plan Strategy (dPS) identified no adverse impacts on Section 75 groups, with the dPS anticipated to have mostly positive effects by addressing environmental, economic, and social needs. Some developments may positively impact specific groups by improving access to housing, jobs, and services. Furthermore, the Addendum in November 2021 reassessed Proposed Changes and found no significant issues, except for Policy HOU 01, which may have a differential impact by addressing specific housing needs in areas with prominent religious groups. It was therefore concluded by PAC that overall, the dPS is expected to positively contribute to equality and social progress.
- 1.4 Dfl accepted the PAC's findings and considered the recommended amendments within the report. In December 2024, Dfl issued a Direction to the Council to adopt the dPS with Modifications, in accordance with Section 12(1)(b) of Part 2 of the Planning Act (NI) 2011. These Modifications were outlined in Schedules 1A, 1B, and 2 of Dfl's Direction. An updated Direction was subsequently published on 5th February 2025, which included updates to Schedule 2, Annex 2, Annex 4, Annex 5, and Annex 6 to address minor errors and omissions.

Categories of Modifications

- 1.5 Schedule 1A lists recommendations that the PAC considered necessary to make the Plan Strategy (PS) sound. These Modifications or corrections, having been proposed by the Council, have no further amendments. The Council had consulted on these Modifications between 9th December 2021 and 3rd February 2022.
- 1.6 Schedule 1B lists Modifications proposed by the Council that the PAC did not consider necessary to make the dPS sound; however, Dfl commended their inclusion in the dPS. The Council had consulted on these amendments between 9th December 2021 and 3rd February 2022.

- 1.7 The Modifications within Schedules 1A and 1B have already been screened for any potential impact on Section 75 groups within the Addendum to the EQIA of the dPS and any further amendments by DfI were minor editing changes which do not alter the nature or intent of the Modifications.
- 1.8 Schedule 2 lists 113 Modifications that are required to make the PS sound. These Modifications are a combination of Council-proposed changes that have been amended, further changes and new changes recommended by the PAC following the conclusion of the IE process. Dfl has updated some of these changes for clarity and consistency. This Second Addendum to the EQIA of the PS assesses these Modifications for any potential impact on Section 75 groups. It also assesses the Modifications in light of representations received from the 2025 public consultation.

Formal Consultation Representations

- 1.9 The Council received 12 representations following the formal consultation exercise. Of these 12, 2 comment on potential impacts on Section 75 groups and/or the EQIA Report and this second addendum. The issues raised are summarised as follows:
 - Screens out modifications without proper analysis of indirect or cumulative effects,
 - Fails to examine how infrastructure pressures could disproportionately impact older, disabled, and low-income rural residents.
 - Does not address potential rural isolation or health inequalities arising from increased development.
 - emerging pressures from potential large-scale data centre developments have not been addressed in the Council's assessments.
 - The Council's assessments fail to consider: the cumulative health impacts of wind energy development, the disproportionate burden on rural vulnerable groups (elderly, disabled, low-income households),
 - The requirement to apply a precautionary approach under public health and environmental law.

2.0 Statutory Requirements

- 2.1 Section 75 of the Northern Ireland Act 1998 places a statutory obligation on all public authorities, in the execution of their functions relating to Northern Ireland, to actively promote equality of opportunity across various dimensions. Public authorities are required to have due regard to the need to foster equality between individuals of differing religious beliefs, political opinions, racial groups, ages, marital statuses, or sexual orientations; men and women generally; persons with disabilities and those without; and persons with dependants and those without.
- 2.2 In addition to the equality obligations outlined above, public authorities must also consider the desirability of promoting good relations. Specifically, while carrying out their functions in Northern Ireland, authorities must strive to foster and maintain positive relationships between individuals of differing religious beliefs, political opinions, or racial groups.

- 2.3 The Disability Discrimination (NI) Order 2006 in line with the Disability Discrimination (NI) Act, 1995 and subsequent amendments made to expand the definition of disability, in line with the Autism Act (2011), introduced further statutory obligations for public authorities. In performing their functions relating to Northern Ireland, authorities must have due regard to the need to promote positive attitudes towards disabled individuals and encourage the active participation of disabled individuals in public life.
- 2.4 The screening of proposed Modifications is an important process that assists in identifying potential issues relating to the Local Development Plan (LDP) and the Planning policies contained within it. This process ensures that any prospective changes are assessed for their differential impacts on equality of opportunity and the promotion of good relations. Through this screening, potential Planning concerns can be proactively addressed, ensuring compliance with statutory equality and good-relations obligations.

3.0 Screening of Modifications

- 3.1 In advancing the Local Development Plan (LDP), the Council is dedicated to ensuring that due regard is afforded to Section 75 groups.
- 3.2 Given the statutory requirement to have due regard to Section 75 groups when developing, adopting, implementing, or revising policies, strategies, and plans, the Council needs to screen Modifications to the dPS. This process ensures identification of whether these Modifications influence the level of impact previously assessed in the EQIA and the first Addendum to the EQIA of the dPS. Modifications listed within Schedules 1A and 1B of the Dfl Direction have already undergone screening for potential impacts on equality.
- 3.3 The Modifications to the PS set out in Schedule 2 introduce changes that have not been previously assessed for their potential impact on equality. Therefore, these Modifications require screening. This Second Addendum to the EQIA of the PS should be reviewed alongside the original EQIA of the dPS and its first Addendum. Readers are also directed, where applicable, to Schedules 1A, 1B, and 2 of the DfI Direction, the updated DfI Direction letter, and associated documents dated 5th February 2025, as well as the PAC's Independent Examination Report concerning the Derry City and Strabane District Council's Local Development Plan 2032: Draft Plan Strategy.
- 3.4 The majority of the proposed changes are considered to be logical and rational amendments to existing policies or policy clarifications, in addition to minor adjustments. The Council has screened all 113 proposed Modifications. Most of these have been considered cumulatively, and it has been determined that these proposed changes present no differential impact on equality.
- 3.5 The results of this assessment are detailed in Table 1 at the end of this document, which focuses on the more-substantive Modifications relevant to equality screening purposes. Table 1 outlines 35 Modifications to the PS included within Schedule 2 of the Dfl Direction and presents the

outcomes of their screening to determine whether any Modifications materially alter the findings of the original EQIA of the dPS or, where applicable, the first Addendum to the EQIA.

- 3.6 These Modifications have been assessed for any differential impacts in comparison to the original or, where applicable, modified dPS strategy or policy. This includes considering the aim of the policy or strategy, the likely impact on Section 75 groups, and any potential cumulative impact resulting from related Modifications.
- 3.7 A Screening Questionnaire which was previously published as part of the dPS, has also been included in Appendix 1. Having reviewed the currently directed Modifications, it is considered that the previously published (December 2019) questionnaire is still valid and useful as a screening framework.
- 3.8 Table 1 of Appendix 2 provides the following:
 - an assessment of whether the selected Schedule 2 Modifications impact the overall aim or purpose of the policy or strategy as previously assessed;
 - an evaluation of whether the Schedule 2 Modifications influence the original EQIA assessment concerning the likely impact of the dPS on Section 75 groups or its overall policy or strategy framework.

4.0 Screening of Representations

- 4.1 In terms of the 12 representations received through the public consultation, these have also been screened and relevant comments (as set out under para. 1.9) are addressed below. Several of these representations provide comment on the draft Plan Strategy policies pre-Modifications and are replications of previous comments. As such, they have been considered under the previous consultation exercises.
- 4.2 One of the representations appears to have misunderstood the purpose of the latest consultation exercise, in that it related solely to the assessment of any further impacts the Modifications (put forward by the PAC and included in the Dfl Direction to adopt the Plan Strategy after it has been found to be sound) potentially may have.
- 4.3 Another commented on 'Just Transition' principles in terms of renewable energy and requested that they and an assessment of their impacts be included in an expanded EQIA. There was no comment on the Modifications and assessment outcomes. It is considered this was assessed in previous EQIA and addendum.
- 4.3 Therefore, the replicated comments, those relating to soundness and those relating to 'Just Transition' principles have been screened out and are not considered in this second Addendum.
- 4.4 In respect of those comments received which disagree with the second addendum as published for consultation or indeed the full EQIA (as an ongoing assessment up to the point of adoption), having fully considered the issues raised in isolation and cumulatively, it

has been determined that neither the second Addendum nor the full overall EQIA require further revision.

- 4.5 Regarding the assertion that the Second Addendum screens out Modifications without proper analysis of indirect and direct impacts, those changes listed and assessed under Table 1 (Appendix 2) are the 'more-substantive' of the Direction Modifications. A review of Table 1 will demonstrate that those screened in are very minor and largely centre on clarificatory text. They do not materially impact the dPS policies. Therefore, those screened out are comparatively more minor again and it would be unreasonable and unnecessary to provide an impact assessment of each.
- 4.6 It was also asserted that the Second Addendum does not examine how infrastructure pressures could disproportionately impact older, disabled, and low-income rural residents, nor does it address potential rural isolation or health inequalities arising from increased development. However, the respondent does not appear to have considered that infrastructure also provides many benefits to the same groups by for example enhancing connectivity between the rural and urban areas and reducing the need for longer journeys for services that can now be more readily facilitated in smaller settlements closer by. Similarly, consolidation of smaller settlements through new development brings more opportunities for health and wellbeing services to be provided by increasing their population density.
- 4.7 Comments were also received in respect of data centres, stating that their impacts have not been addressed in the Council's assessments. While there may be no direct mention of this specific type of development, it has been considered under the assessment of any and all policies applicable to such proposals; as is the case with many types of development that are not directly referred to. The assessment of impacts of these (and all policies) were carried out in the previous EQIA and addendum.
- 4.8 Lastly, a comment stated that there is no evidence that the equality duty under Section 75 was considered in terms of the impacts on rural communities and protected groups. A thorough review of the original EQIA and First Addendum, read in conjunction with this Second Addendum contradicts this. All documents clearly set out the impacts to be assessed, the assessment and the outcome. In any event, comments were invited in relation to the DfI Direction Modifications. The previous two assessments have already considered all policies in relation to these and other Section 75 groups. They have been subject to independent examination by the PAC and accepted by DfI subject to the Modifications.

5.0 Conclusion

5.1 The Modifications to the LDP Plan Strategy do not introduce any new policies and they vary in nature. These include minor editing corrections to address typographical errors and corrections to ensure factual accuracy. Other amendments are logical changes to strategies or policies and associated text to enhance coherency and consistency.

- 5.2 The assessment informing this Addendum has determined that the Modifications do not materially change the aims or influence of the policies or strategies to which they relate. Nor have they impacted the overall 'Vision' for the District as set out in the PS.
- 5.3 The majority of the Modifications have been screened out as having no differential impact on equality. These are not considered further in this Addendum and can be viewed in Schedule 2 of the Dfl Direction. Table 1 additionally considers those changes identified as being more-substantive for equality screening purposes.
- 5.4 The only Modification of note that the assessment identified was the proposed change to economic development Policy ED 4, as it could have a differential impact on equality. The Modification would slightly expand the ED 4 Justification and Amplification wording to state: 'Particular care is needed to avoid soft play areas, jump zones, care settings, etc. that can attract the public and vulnerable users such as children, those with disabilities.' This change would provide a minor positive impact on Section 75 groups, particularly individuals with disabilities, by offering clarity for developers and ensuring the needs of vulnerable users are duly considered.
- 5.5 Upon reassessment of the findings of the original EQIA, the first Addendum concerning the proposed Modifications and the public representations, it is concluded that these outcomes remain unchanged. Therefore, the proposed changes do not alter the likely impact of the LDP Plan Strategy on Section 75 groups, nor do they affect the level of regard given to equality.
- 5.6 The LDP will also be subject to further equality screening at the Local Policies Plan stage. Monitoring and reviewing the LDP is an integral part of the plan-making process. The LDP draft Plan Strategy includes a Monitoring and Review Framework, which highlights that a five-year review will be conducted post-adoption to ensure that policies and proposals achieve their objectives. There will be further scope for equality impacts to be considered during this review.
