**Freedom of Information Act 2000 Request 'Call In' Decisions**

I refer to your FOI request as above and respond as follows:

Council is not required to provide copies of this information as the information has already been published (exemption s22 of the Freedom of Information Act 2000).

I can confirm that one further request for a Call In of a decision has been received and the matter has not yet concluded. The Call In was requested under both sections 41(1)(a) and 41(1)(b) of the Local Government Act (NI) 2014.

I attach a copy of the request for Call In and can confirm that legal counsel opinion has been sought however has not been provided to date. On receipt of same, Council will provide a copy of the opinion to Members and where the Call In has merit will make arrangements for reconsideration of the decision by Council.

I trust the above addresses your query. If you are dissatisfied with our response you have rights of review and appeal; these rights consist of two review processes.
