## Road Traffic Regulation (Northern Ireland) Order 1997 Notice of Proposed Road Closures for a Special Event

Notice is hereby given that, by virtue of the powers conferred on it by Article 8A of, and Schedule 3A to, the Road Traffic Regulation (Northern Ireland) Order 1997, Derry City and Strabane District Council is minded to make an Order to temporarily restrict or prohibit vehicles from using the roads detailed in, and in accordance with, the following schedule. The purpose of the Order is to facilitate a Special Event, known as the **Cathedral Quarter Pedestrianisation – Pilot Programme**, which is being held by **Derry City and Strabane District Council on 4th – 5th September 2021**, between the hours of **06:00 am and 12:00 midnight**, each day.

### Schedule of planned road closures:

Street / road to be closed	Extent of restriction	Type of restriction:
<b>Magazine Street Upper</b>	From its junction with Butcher Street up to its junction with Society Street	Full Road closure
<b>Society Street</b>	From its junction with Magazine Street Upper up to its junction with Bishop Street	Full Road closure
<b>Palace Street</b>	From its junction with Bishop Street up to its junction with Society Street	Full Road closure
<b>London Street</b>	From its junction with Bishop Street up to its junction with Artillery Street	Full Road closure
<b>Pump Street</b>	From its junction with London Street up to its junction with Ferryquay Street	Full Road closure
<b>Artillery Street</b>	From its junction with Ferryquay Street up to its junction with London Street	Full Road closure

Where necessary, local diversion routes will be in operation and signposted in accordance with a Traffic Management Plan that has been prepared specifically for this event.
